



"WILDLIFE ART "
APPLICATION FOR JURIED EXHIBITION
DEADLINE NOVEMBER 15TH 2008

The Ciao Art Gallery in Jackson, Wyoming announces a call to artists for the "Wildlife Art Exhibition", to be held November 29th- December 19th 2008.

Eligibility:

- Work must contain wildlife as the subject matter.
- Work can be any size, shape, medium, style, in 2 or 3 dimensions and is open to all.
- Work must be ready to hang, and clearly labeled with the artists name and contact information.
- No substitutions of accepted work.
- All work will remain on display during the duration of the exhibit.
- Art work must be for sale.

Calendar:

- Submissions must be received on or before November 15, 2008 (November 13th for postmarked submissions).
- All those who have entered will receive a reply on November 18th, 2008.
- All chosen artists work must be delivered by November 28th, 2008.
- All chosen artists will feature their work at a special Wildlife Exhibition, November 29th 2008, which will continue to be displayed, in the front exhibition space of CIAO Gallery, until December 19th, 2008. The reception will be highly publicized and open to the public.
- Art is to be picked up December 19th, 2008 (or will be shipped to you).

Prizes:

1st Place- Selected pieces will be featured in gallery space for 3 months with no exhibition fee, and 6 months free representation in featured artist section on gallery website.

2nd Place- 6 months free representation in featured artist section on gallery website.

3rd Place- 3 months free representation in featured artist section on gallery website.

Jurors: Kari Hall, curator Ciao Gallery, and Michele Walters owner Ciao Gallery, Guest Juror , Wildlife Art Expert (please see attached for Juror qualifications).

Online Submission Guidelines

Prepare images for online submission as follows:

1. Obtain a digital image of the work in .JPG format.
2. Crop out mats, frames, etc.
3. Crop image so that longest dimension is 900 pixels.
4. Set the image resolution at 72 ppi.
5. Label the image using last name, first letter of first name, and the number that corresponds to the entry form image (e.g. SmithJ1 for John Smith first image).

Send e-mail to: ciaogallery@yahoo.com. Please be sure to include "juried show app" in the subject line and the following information in the body of your e-mail for each entry:

1. Image File Label (e.g. SmithJ1).
2. Title of Work.
3. Medium.
4. Size of Work (framed size for 2-D, dimensions for 3-D).
5. Price of Work (including 40% commission).
6. Send a check payable to CIAO Gallery to PO Box 763, Wilson WY 83014 (See fee Schedule below). Online applications that have not paid the fee by November 15th will not be reviewed .

Application Fee & Commission Agreement: There is a \$35 application to submit up to 5 digital images to be considered for the exhibition, \$5 each additional, up to a total of 10 works. This fee must be returned with the application and artist's submissions. This is a non-refundable fee. Chosen artists work will remain on display, in the exhibition space of CIAO gallery for a period 3 1/2 weeks following the opening reception for the exhibition. The Exhibition will include advertising, entertainment, and refreshments. Any art sold will be commissioned by CIAO at a percentage of 40% /60% to the artist.

Acceptable Image Submissions:

All submissions must include a self-addressed envelope. Do Not Send Original Artwork!

Please submit up to 5 images, any additional images are a \$5 charge per submitted image.

CD:

Acceptable formats: jpeg.

Prints or Photographs:

All material must easily fit into an 8.5" X 11" envelope.

CIAO Gallery is not responsible for loss or damage to your work, therefore artists are responsible for insuring their own work. Once your work is in the gallery, CIAO takes extensive measures to ensure the safety of your artwork.
